**Sub: Strike off from the Register of Companies of M/s Chhattisgarh Surguja Power Limited
on January 11, 2023, a wholly owned subsidiary of Power Finance Corporation Limited**

Madam/Sir,

This is to inform that Chhattisgarh Surguja Power Limited (CSPL), a wholly owned subsidiary of Power Finance Corporation Limited (PFC) has been Struck off from the Register of Companies and the said company is dissolved on 11.01.2023.

CSPL was incorporated on 10.02.2006 as wholly owned subsidiary of Power Finance Corporation Limited for development of 400 MW Ultra Mega Power Projects in the State of Chhattisgarh. Subsequently, MoP vide their letter 06.06.2016 directed to take necessary action for closure of the Company. Accordingly, the Board of Directors of CSPL & Power Finance Corporation Limited approved the closure of 4000 MW CSPL and striking off the name of the Company from the records of Registrar of Companies.

Accordingly, necessary documents were filed with the Registrar of Companies for striking off and dissolution of CSPL from the records of Registrar. Now, MCA vide its 'Notice of Striking off and Dissolution' dated 11.01.2023 has published that pursuant to sub-section (5) of Section 248 of the Companies Act, 2013 the name of M/s CHHATTISGARH SURGUJA POWER LIMITED has 11th day of January, 2023 been struck off the register of companies and the said Company is dissolved.
